

In addition, please be advised, that a provision in the Florida Statutes requires that a certified statement that the newly elected Board Member has read all the governing documents of the Association and they will uphold such documents responsibly and faithfully to the best of their ability OR they must attend a New Board Member Certification Course. Either Certificate must be completed and submitted within 90 days of being elected. If you wish to be considered a candidate for election, please fill in the blanks below and return it to the office by 6 p.m., Monday, February 14<sup>th</sup>, 2022 with a brief description of yourself, your experience or education and why you are running for the Board of Directors. All information must be received on time to be mailed out to the residents in time for the election.
